### **New Resource for Research to Promote Clinical Preventative Services**

The new [Clinical-Community Relations Evaluation Roadmap](#) is a resource for future research into and evaluation of the design and implementation of effective relationships between primary care practices and community organizations to promote increased availability of clinical preventive services. The roadmap was produced for the U.S. Department of Health and Human Services' Agency for Healthcare Research and Quality. It presents background and priority questions and recommendations.

### **Helping Home Visitors Build Protective Factors in West Virginia**

Strengthening Families West Virginia developed a booklet, [Strengthening Families through In-Home Family Education](#), that explores the many ways that evidence-based early childhood home visitation (In-Home Family Education) programs can build protective factors and implement the Strengthening Families approach. The 20-page booklet provides an overview of the Strengthening Families Protective Factors Framework and includes activities and approaches that home visitors can use to build protective factors with the families that they serve. The document also describes related statewide and national initiatives and training opportunities for home visitors who want to learn more about Strengthening Families.

### **Five Protective Factors – or Six?**

Historically, there has been some confusion about whether there are five or six protective factors in the Strengthening Families Framework. ### **Better for Babies: A Study of State Infant and Toddler Child Care Policies**

[This paper from the Center for Law and Social Policy](#) presents data from a recent state survey of childcare subsidy, licensing, and quality enhancement policies. It provides a national picture of infant-toddler childcare, including information on both center and home-based childcare. Overall, the paper finds, states have displayed good intentions by creating and implementing policies that support infants and toddlers. However, the data gathered show that state policies for licensing,

subsidy, and quality enhancement are not yet meeting the needs of infants, toddlers, and their families.
