

Aims To Improve Children's School Readiness And Overall Child And Family Well-being

By focusing on the levers of social and emotional development of children 0-3 and strengthening parent-child relationships.

- The initiative does this by partnering with primary care providers, parents, and families to transform pediatric well-child visits
- These well-child visits address children's health and development, but often miss opportunities to promote social and emotional development which is an early indicator of school readiness and is primarily driven by parent-child relationships.
- Unfortunately, structural barriers such as limited time, insufficient provider reimbursement, incompatible electronic medical records/technology inefficiencies, lack of measures to assess progress, and insufficient training for providers make it hard for the typical visit to embrace this new focus.



PSP Phase 2 Strategy Overview

In Phase 2, the Pediatrics Supporting Parents (PSP) initiative seeks to achieve concrete changes in pediatric primary care in a few proof point communities and strengthen the enabling conditions at the state and national levels to build momentum and create a roadmap for universal adoption of common practices in well-visits.

Background - Phase I

Pediatric Supporting Parents Initiative (PSP)

 What is the potential utility and benefit of an integrated modular technological platform in the well-child visit setting?

Help Me Grow National Center Focus

 Understand provider and parent demand, and technological feasibility, for tools that seeks to increase parent engagement with the well-child visit and strengthen pediatric capacity to promote children's health and development, including social-emotional development, in the well-child visit setting.

Approach

- Parent perspectives on value/feasibility (Web-based survey)
- Provider perspectives on value/feasibility (Web-based Survey)
- Analysis of integration potential (Patient Tools, Inc.)
- Key stakeholder interviews (Various field leaders)

Recommendations – Phase I

- Build a Product
 - Tools to include?
 - How best to interface with other sectors and settings?
- External Guidance and Feedback
 - Guide development with input from key advisors representing, among other areas:
 - Assessment domains, question logic, psychometric properties, parent voice, provider perspective, EMR integration, IP/legal, etc.
- Determine Integration Features
 - Modularity for practices (provider/parent choice)
 - Prescreen component
 - Actionable results
 - Publishable format to support implementation in EMR
- Implement and Test the Product
 - Feasibility
 - Different pediatric settings
 - Interface with community-based support for promotion, early detection, referral and linkage through Help Me Grow

Planned Activities - Phase II




Our Vision

- 1. Truly implement a parent-led agenda
- 2. Emphasis on eliciting and responding to parents' opinions and concerns
- 3. Focus on developmental promotion, early detection, referral and linkage... not screening tools in isolation
- 4. Enabling cross-sector data sharing
- Address existing barriers to achieving the four goals above by creating novel ways to merge evidence-based tools into a single platform, streamlining the process for parents and providers and maximizing opportunities to promote optimal development

Systemic Solution



Trigger Effective Actions

- Early detection with stepped level of care and 100% reach
- What domains should be monitored based on age
 - Child, parent, environment
 - Developmental, relational, psychological
 - Social determinants, safety (food, housing, abuse, etc.)
 - Trauma, trajectory, resilience
 - ...
- Effective actions tailored to the setting
 - Provider facing results for green, yellow and red
 - Parent facing results for green, yellow and red
 - Eliciting concerns/parent priorities that drive further discussion
 - Strengths based engagement and education
 - Logic based linkage to education, activities and resources
 - ...




Target Domains (Required/Desired)

- Developmental (AAP, 3x first 3 years)
- Autism (AAP, 2x in second year)
- Behavioral (AAP, regular checks starting at 1 year)
- Parent engagement
- Environmental
 - Postpartum depression
 - Social determinants, risks/protective factors
 - Family strengths/needs
- Relational
- Trauma
- ...

Target measures

Dynamically combine using subdomains, enables, prescreens and triggers

- **SWYC** (development, behavioral, environmental) > milestones, inflexibility, irritability, routine, social interaction, symptom checklist, tobacco, substance, nutrition, health, women abuse
- **WVP/PHDS** (parent engagement) > strengths & concerns, priorities, history, demographics, SWYC
- **WECS** (relational) prescreen for full WECS evaluation
- **FINDConnect** (environmental) evaluation for access to services/resources
- **ASQ-3** (developmental, parent engagement) > communication, gross motor, fine motor, cognitive, socialemotional, parent comments
- **ASQ:SE-2** (behavioral) > self-regulation, communication, adaptive functioning, autonomy, affect, interaction with people, parent comments
- **M-CHAT-R** (autism) > screener for performing a full evaluation
- **EPDS** (environmental) > parent postpartum depression
- **SDoH** (environmental) > access to health care/education, isolation, safety food, housing, financial and physical
- **PCL-C/ACE** (trauma) > prescreen for PTSD/adverse childhood experiences
- **ESQ** (environmental) > family strengths/needs, environmental risks/protective factors
- **SEEK** (psychosocial) > risk factors for child maltreatment

PSP Phase II Advisory Group Activities
