

# Outreach Coordinator Network

## *Call for Co-Chair Applications*

***The Help Me Grow National Center invites those in outreach and engagement roles from across the National Affiliate Network to apply to co-facilitate and lead the 2022-2023 Outreach Coordinator Network (OCN) retreats.***

The HMG Outreach Coordinator Network retreats are an opportunity for outreach and engagement staff of HMG systems to connect, share best practices, and problem-solve with staff in similar roles across the nation. The HMG National Center works with Co-Chairs who work in outreach and engagement roles to plan and help lead these retreats on a quarterly basis.

To ensure the OCN continues to reflect the diverse perspectives, ideas, and needs of the National Affiliate Network, we are seeking one or two new Co-Chairs to lead the next year of OCN retreats. The OCN Co-Chair roles and responsibilities, commitment, incentive and application process are outlined below.

### ***Roles & Responsibilities***

- Attend monthly planning phone calls to identify topics, speakers, meeting structure, etc.
- Research possible speakers/resources to share
- Develop a survey or another mechanism to solicit priorities for session topics from the OCN participants and review data collected
- Attend one 2-hour Network Retreat per quarter (four annually)
- Assist in finding note-takers for breakout sessions and collating notes from each retreat to send back to the HMG National Center
- Respond to regular emails discussing upcoming retreats
- Review feedback from previous events

### ***Commitment***

- *Duration:* OCN Co-Chairs will contribute to retreat planning and efforts between September 2022 and August 2023.
- *Expected time commitment:* OCN Co-Chairs should anticipate spending approximately 5 hours per month on OCN-related tasks; actual time spent may vary.

# HELP ME GROW OUTREACH COORDINATOR NETWORK LEADERSHIP FAQ

## ***Incentive***

To recognize the time and effort provided by OCN co-chairs, the National Center will pay \$1,200 to each leader (either the individual or their organization) for the year of leadership

## ***Application process***

### *Eligibility criteria:*

1. Applicants must serve in a role that carries out work to outreach/engage stakeholder groups (such as families/caregivers, community-based partners, and/or physicians) for a HMG system at any stage of implementation of the HMG Model (e.g. representatives from both new and long-standing HMG systems are encouraged to apply.)
2. Applicants must be willing, able, and commit to the outlined responsibilities and commitments associated with the Co-Chair role.
3. Applicants must be able to attend the OCN retreat on September 20, 2022 from 4:15-5:00pm ET; and must also attend a planning call in advance of that session (planning call date TBD based on availability).

*Application:* The OCN Co-Chair application is available online and due by Friday, August 19, 2022. Applicants will be selected based on the criteria above and notified of acceptance by August 26, 2022.
